**Comments on Inspection:** Site contaminated in vicinity of separator approximately 30 feet towards wellhead. Tank battery on site has leaked and impacted pasture to the east along road entrance to well site. Two pooling areas saturated along this flow path. Remediation Required. Contact NMOCD District 2 Environmental Compliance Officer to discuss remediation requirements.

**Comments on Inspection:** Wellhead area heavily contaminated. Remediation Required. Site had release in 2004, microblaze applied. Eastern edge of site has heavy staining, apparently from previous spill. Runoff from this area has pooled into and impacted pasture. Remediation Required. Contact NMOCD District 2 Environmental Compliance Officer to discuss remediation requirements.

In the event that a satisfactory response is not received to this letter of direction by the "Corrective Action Due By:" date shown above, further enforcement will occur. Such enforcement may include this office applying to the Division for an order summoning you to a hearing before a Division Examiner in Santa Fe to show cause why you should not be ordered to permanently plug and abandon this well. Such a hearing may result in imposition of CIVIL PENALTIES for your violation of OCD rules.
