NOTICE OF VIOLATION - Inspection

Dear Operator:

Comments on Inspection: Location needs attention. Equipment OK. Contamination along northern side of location along road and between wellhead and tank battery. Contaminated soils inside tank battery berm. Contamination has run off location on south east corner and pooled approximately 25 feet from flowline pump. Pooling area has impacted pasture. Remediation required. Contact NMOCD District 2 Environmental Compliance Officer to discuss remediation requirements.

In the event that a satisfactory response is not received to this letter of direction by the "Corrective Action Due By:" date shown above, further enforcement will occur. Such enforcement may include this office applying to the Division for an order summoning you to a hearing before a Division Examiner in Santa Fe to show cause why you should not be ordered to permanently plug and abandon this well. Such a hearing may result in imposition of CIVIL PENALTIES for your violation of OCD rules.
