Drilling pit contents will be excavated and hauled to Unit J, Section 26, T6S, R25E Cottonwood Federal 5 API # 30-005-63448. The encapsulation trench will be lined with a primary 12 mil liner. The drilling pit material will then be emplaced into the encapsulation trench located at the Cottonwood Federal 5 and capped with a 20 mil synthetic liner.
