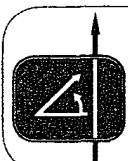

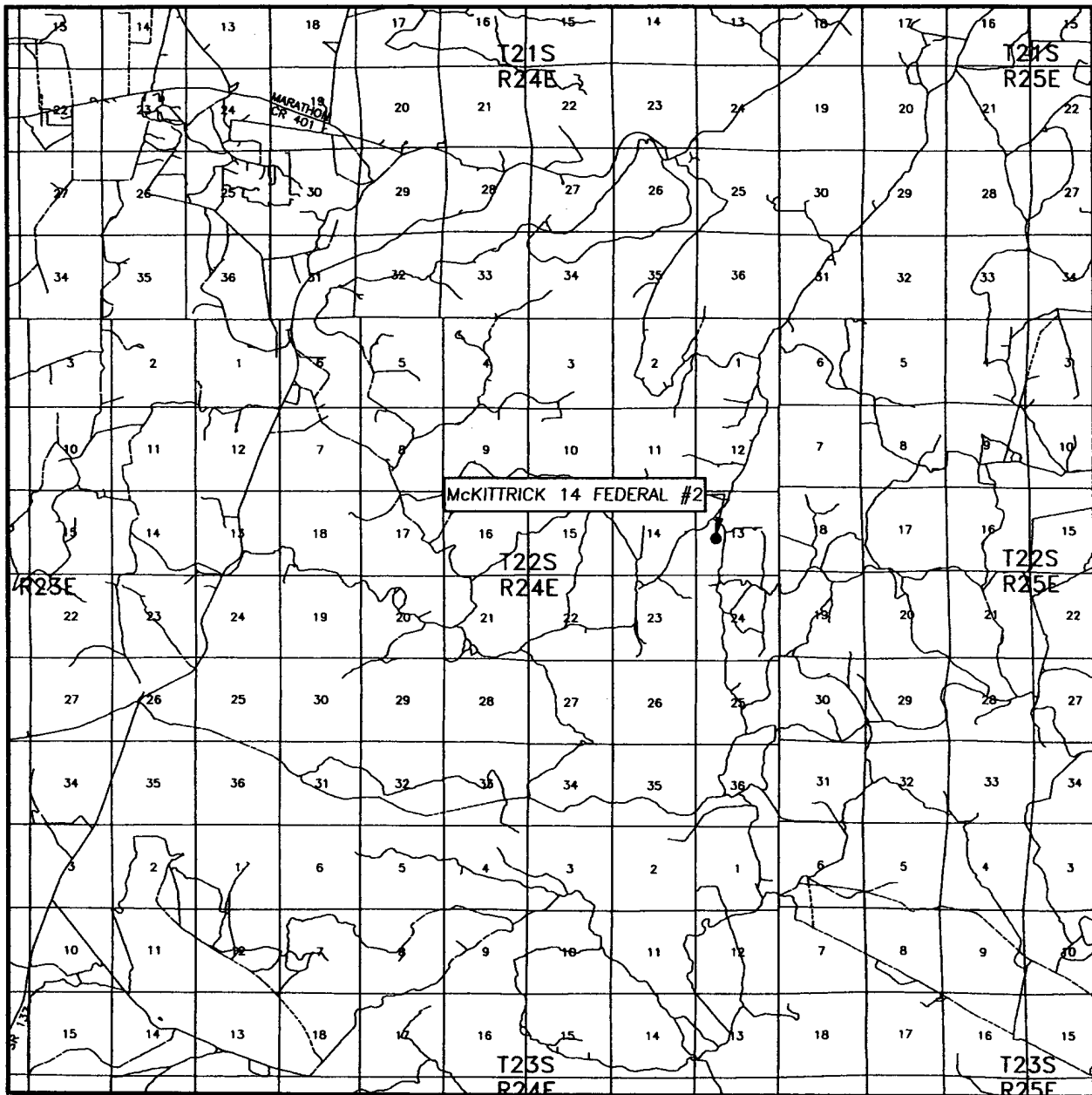
McKITTRICK 14 FEDERAL #2 WELL

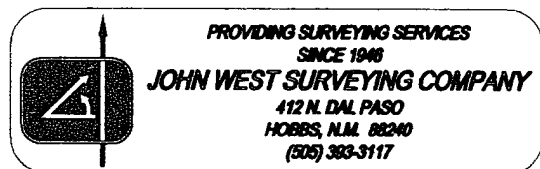

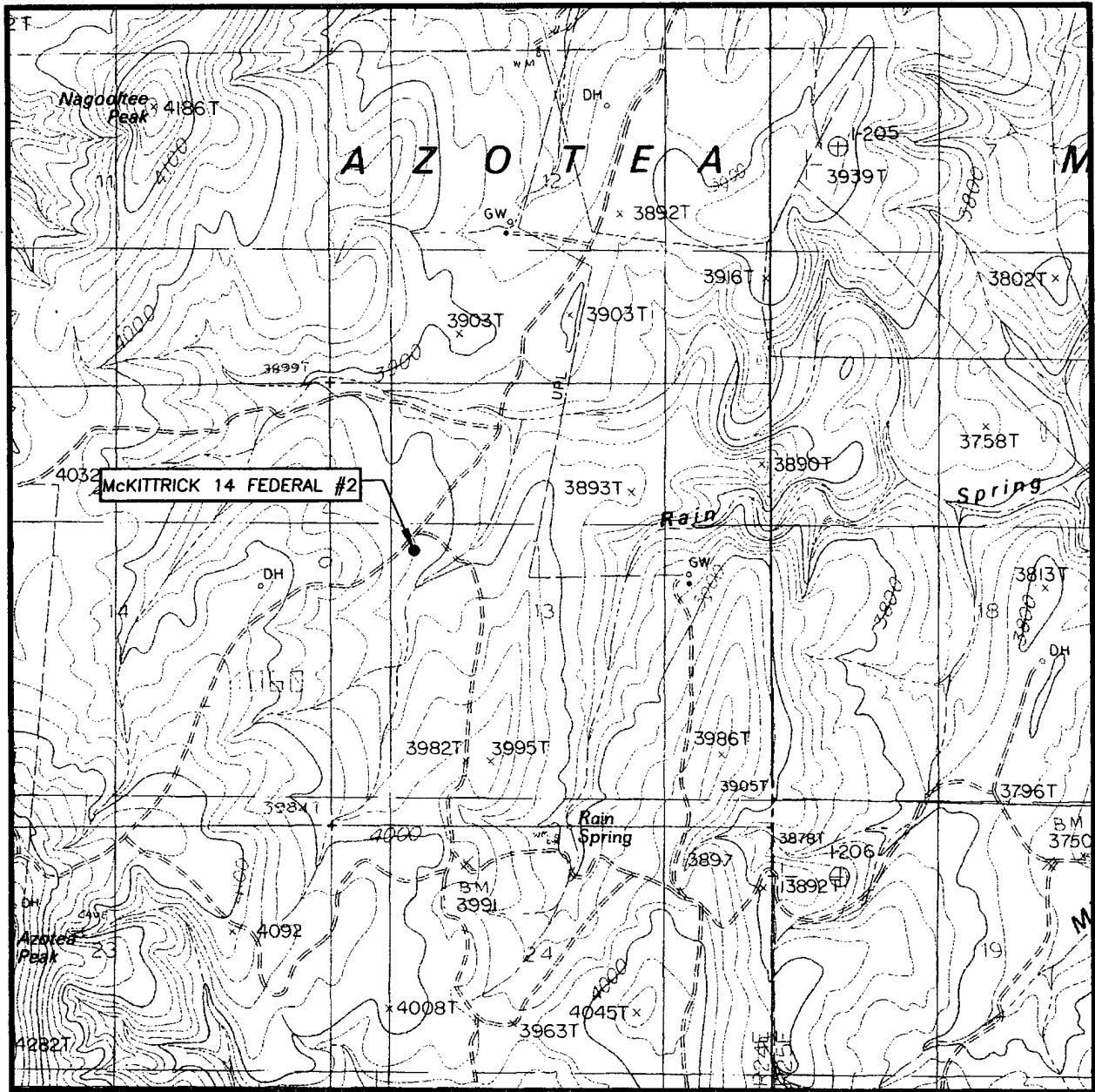
