Tested perforations from 10,076' to 10,084'; recovered 5 barrels water with continuous gas flare.

Reset RBP at 10,059' and reset packer at 9964'. Tested perforations 10,048' - 10,056' K.B.

Swab and flow tested recovering 97 barrels water with strong gas blow.
