Cemented with lead of 150sx Premium Plus + 10# CalSeal + 10# Gilsonite + 2% CaCl + 1/2# Flocele and tail of 225sx Premium Plus + 2% CaCl. Did not circulate any cement. Ran 1" on backside of casing and found TOC at 75'. Pumped 50sx Premium Plus + 3% CaCl. One-inched to 36' and pumped 40sx Premium Plus + 3% CaCl. Circulated 10sx to cellar.
- 07-20-05 WOC 19.5 hours. Tested casing to 1000psi.
- 07-23-05 Ran 44jts 9-5/8" 40# N-80 8rd LTC casing to 1892'. Cemented with lead of 680sx Interfill C + 1/4# Flocele and tail of 200sx Premium Plus Class C + 2% CaCl. Circulated 74sx to pit.
- 07-27-05 WOC 24.5 hrs. Tested casing to 2000psi.
