Comments on Inspection: No Well Sign (Rule 103). Heavy chloride deposits on north side of wellhead. Heavy contamination from pumpjack motor fluids running off to southwest across location. Remediation required. Contact NMOCD District 2 Environmental Compliance Officer to discuss remediation requirements.
