Comments on Inspection: Tank battery has contamination inside berm. Saturated soil/gravel along back side of tank battery need to be removed and backfilled with clean material. Where the berm is contaminated that material needs to be removed and replaced with clean material. Below grade sump (or tank) has saturated soils inside boxed area and contaminated soils along flowlines. Remediation of the tank battery is required. Contact NMOCD District 2 Environmental Compliance Officer to discuss remediation requirements.

In the event that a satisfactory response is not received to this letter of direction by the "Corrective Action Due By:" date shown above, further enforcement will occur. Such enforcement may include this office applying to the Division for an order summoning you to a hearing before a Division Examiner in Santa Fe to show cause why you should not be ordered to permanently plug and abandon this well. Such a hearing may result in imposition of CIVIL PENALTIES for your violation of OCD rules.
