Devon Energy Production Company, LP is applying with the NM OCD for approval to downhole commingle the Red Lake Queen-Grayburg-San Andres (51300) and the Northeast Red Lake Glorieta Yeso (96836) pursuant to 19.15.5.303 (C) 3 (b) Exceptions for wells located in pre-approved pools or areas. This pool was pre-approved by NM OCD Division order PC-1108.

The San Andres is perforated at 1952-2385' and the Yeso is perforated from 2944-3216'. Average production from the SA is 12.5 oil and 117.6 gas. Average production from the Yeso is 21.4 oil and 143.4 gas.

The allocation method is by ratio of stabilized production. For the Yeso, oil is 63.1% and gas is 54.9%. For the San Andres formation, oil is 36.9% and gas is 45.1%.

Commingle these two pools will not reduce the value of the total remaining production and the ownership between the two pools is identical.
