Bass Enterprises Production Company respectfully request permission to deviate from the APD stipulation for the Poker Lake Unit # 234 requiring any permanent equipment installed on location be no taller than 7'. Bass proposes to install a smaller 320 pumping unit which will stand approximately 25' tall instead of the 640 and 912 pumping units that we typically use which are in excess of 40' tall. Newly developed motor controllers will be used in order to lift the volume of fluids required with the smaller pumping units. No other means are economically available to effectively pump these wells from the depth of the formations produced.
