The subject well produces with a high water cut. The well was shut-in pending installation of a saltwater disposal line on State lands. A row was obtained from the State of NM and the saltwater disposal line has now been installed. The line transfers produced water from the Keys Battery to the Vanguard operated Barber Battery, and is disposed in the Vanguard operated State No. 002 SWD. The State No. 002 SWD (API 30-015-04686) is located in Unit Letter N, Section 17, T20S, R30E. The Keys No. 7 well has been restored to full time production. The well is producing by means of a submersible pump. The well was placed on test on 10/19/2012 and produced 3 BO, 280 BW in 24 hrs.
