BOPCO, L.P. respectfully requests approval to install a 8" buried steel welded gas line for +/- 3311' +/- . The line will begin at the Poker Lake Unit #261 battery located in section 21, T-24-S, R-30-E. The gas line will run north following three existing BOPCO gas lines and a 8" oil line and be within 5' of the existing gas line. The gas line will tie into a Enterprise gas line that was previously installed. The gas line will operate at +/- 550 psig. A sales meter will be installed at the Enterprise connection. The gas line will replace an existing 4" gas line that is under sized and help eliminate current gas flaring. BOPCO will set 2 compressors on the Poker Lake Unit #41 location just north of the 261 battery. The route has been previously arch cleared. A survey plate of and map of the gas line is attached.
