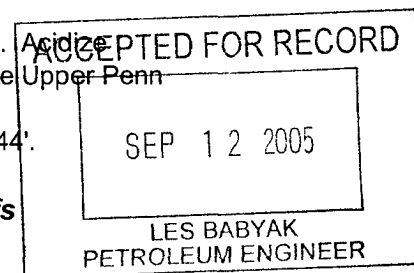
8/16/05 Perforate Upper Penn 6390'-6464' (75). Acidize with 3000g gelled 20% IC HCL.

8/19/05 Perforate Upper Penn 6072'-6082' (11), 6106'-6110' (5), 6150'-6164' (15), 6188'-6194' (7), 6200'-6212' (13), 6236'-6268' (33), 6320'-6334' (15) and 6344'-6350' (7).

8/22/05 Acidize Upper Penn 6320'-6350' with 1500g 20% IC HCL with 33 ball sealers. Acidize Upper Penn 6236'-6268' with 2000g 20% IC HCL with 50 ball sealers. Acidize Upper Penn 6072'-6212' with 3000g 20% gelled IC HCL with 76 ball sealers.

8/30/05 Drilled composite plug at 8425' and pushed down to 8546'. Set packer at 8344'.
