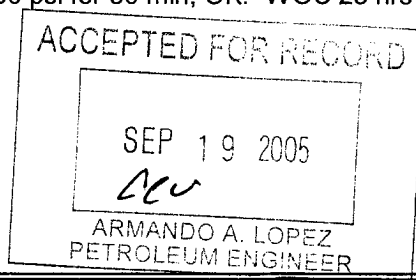

8/28/05 Set 8-5/8" 24# casing at 1125'. Cemented with 500 sx 35:65:6 "C" + 5% D44 + 3% S1 + 5#/sx Gilsonite + .25% Celloflake + .2% D46 (yld 2.1, wt 12.6). Tailed in with 200 sx "C" + 2% CaCl2 (yld 1.32, wt 14.8). Cement circulated to surface. WOC. Tested casing to 1600 psi for 30 min, OK. WOC 23 hrs 30 min. Reduced hole to 7-7/8" and resumed drilling.
