Apache Corporation would like to request a variance from the approved interim reclamation that was submitted along with the APD. The interim reclamation plat showed that we were to remove a small area located on the NW and NE corner of the pad by 70'. Due to the fact that we have three access roads into this location instead of the one originally stated, which the extra road go to other wells on the lease, we will need to keep the NE section of the pad open. The approved plat showed the location to be 225x270, but was built as 225x256. Apache would like to request that we reclaim the northwest corner by 77 to north and 43 to west as well as take 88' from the southwest corner. Drawing attached.

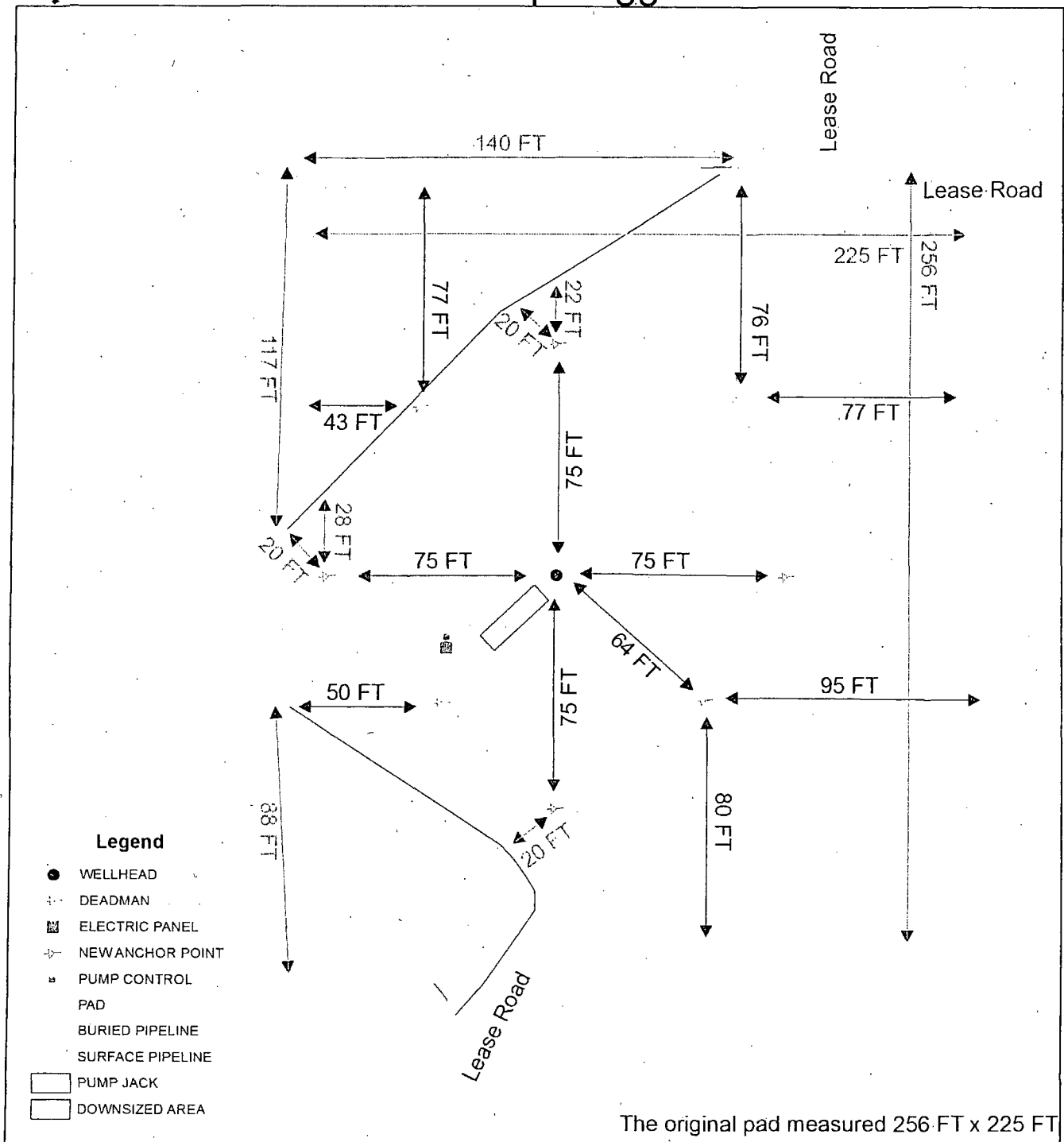
