Soon after circulating cement to the surface on the production casing cementing job, the ESDU 28 developed flow and pressure built between the 8-5/8" and 5-1/2" casing annulus. SM Energy request permission to establish a pump rate down the annulus and pump additional cement down the annulus to preserve the integrity of the pipe and seal off the pressure and flow that has developed in the backside. A pressure transducer will be rigged up to monitor the backside during stimulation operations.
