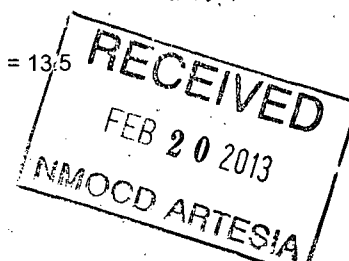

Tail: 200 sks of Class C ("C" Neat) Yield = 1.34, density = 14.8

Circulated 60 bbls/192 sks of cement to surface.

On 10/10/12, tested the casing to 1,500 psi for 30 minutes = OK
