9/16/05 - Notify BLM. Move in steel pit. NDWH. NUBOP. Rods parted. POOH w/ 37 5/8" rods. RIH w/ new box to screw back on parted rods. Well started flowing water. Flow down well 1 1/2 hrs. Pump 30 bbls brine to kill well. Can't unseat pump. Back off rods. Ld 37 rods. CWI.

9/17/05 - Pump 20 bbls brine to kill well. POOH w/ rods & tbq. Stripping out rods. RIH w/ gauge ring to 1,330'. Set CIBP @ 1,330'. Dump 35' cement on top. RIH w/ tbq & Circ. Fluid to surface. Close BOP. Test to 500# for 30 minutes. POOH w/ tbq. NDBOP. NUWH. RD. Well is temporarily abandoned on 9/17/05.
