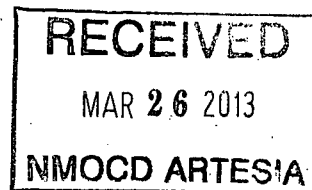

Plug down @ 3:30 AM 02/11/13. Circ 64 sks of cement to pit. WOC. At 12:30 AM 02/12/13, tested csg to 1500# for 30 mins, held OK. Drilled out with 8 3/4" bit.
