

Yates Petroleum Corporation plans to recomplete this well as follows: Plan to test for casing leaks and repair if necessary. Set a composite flow thru plug at 11,026'. Perforate Atoka 10,724'-10,731' (43). Stimulate as needed. Set a composite flow thru plug at 10,674' and perforate Strawn 10,189'-10,206' (18). Stimulate as needed. Plan to commingle the Morrow, Atoka and Strawn after YPC receives approval.

NOTE: Baker Loc Set w/on-off & 1.81" profile (this packer is still in hole w/broken collar) at 11,112'.
