09/22/05...TD'ed 17 1/2" hole @ 1953'. Ran 1953' 13 3/8" 54.5# J55 ST&C Csg. Cemented with 1100 sks (35:65:6) BJ Lite Poz Class "C" with additives. Mixed @ 12.5 #/g w/ 1.98 yd. Tail with 400 sks Class C with 2% CaCl2. Mixed @ 14.8 #/g w/ 1.34 yd. Did not circulate. RIH with 1" pipe and tag @ 420'. Cmt w/340 sks Class C neat. Mixed @ 14.8 #/g w/ 1.32 yd. Circulate 20 sks to pit. WOC 18 hrs. At 5:45 am on 09/23/05, tested casing to 1925# for 30 minutes, held OK. Drilled out with 12 1/4" bit.
