

13. Describe Proposed or Completed Operation: Clearly state all pertinent details, including estimated starting date of any proposed work and approximate duration thereof. If the proposal is to deepen directionally or recompleate horizontally, give subsurface locations and measured and true vertical depths of all pertinent markers and zones. Attach the Bond under which the work will be performed or provide the Bond No. on file with BLM/BIA. Required subsequent reports must be filed within 30 days following completion of the involved operations. 1. Reenter the well.
2. Clean out any fill to about 2200'.
3. Swab well to determine oil cut.
4. Run in hole with 2 3/8" tubing with pump seating nipple at about 2120'
5. Run rod insert pump and rods.
6. Space pump out .
7. Set pumping unit.
8. Hook up bridal and horses head.
9. Set tanks, install pumping T and connect flow line to tanks.
10. Bring electricity onto location.
11. Set standard electric control panel.
12. Connect electric power to control panel
13. Connect control panel to electric motor on pumping unit.
14. Turn on pumping unit and produce well.
15. Gage tanks daily. Turn in subsequent Sundry report.

It well proves to be uneconomical. Plug as per approved procedure


