Drilled 7-7/8" hole to TD4650' on 5/12/13. Ran open hole logs. Set 5-1/2" 17# J-55 production csg @ 4646'. Cmted w/lead 300 sx (573 cf) 65/35 poz "C" cmt w/5%(BWOW)PF44, 6%PF-20, 0.2% PF-013, 0.125# PF-29, 0.4# PF-46, 3# PF-42 & tailed w/675 sx (905 cf) cl "C" cmt w/0.5% PF-167, 0.2% PF-65, 0.125# PF-29, 0.4# PF-46. Circ 150 sx cmt to pit. Released drilling rig on 4/14/13. Plan to pressure test 5-1/2" csg before completion operations.
