Spudded well on 6/1/13. Drilled 12-1/4" hole to 410'. Set 8-5/8" 24# J-55 csg @ 402'. Cmted w/280 sx (375 cf) cl "C" cmt w/2% Cacl2 & 0.25# C/F. Circ 92 sx cmt to pit. On 6/2/13, pressure tested 8-5/8" csg to 1500 psi for 30 min-OK.

Drilled 7-7/8" hole to TD4659' on 6/7/13. Ran open hole logs. Set 5-1/2" 17# J-55 production csg @ 4659'. Cmted w/lead 200 sx (380 cf) 35:65 poz "C" cmt w/5% PF-44(BWOW), 6% PF-20, 0.2% PF-13, 0.125# PF-29, 0.25# PF-46, & 3# PF-42 & tailed w/695 sx (924 cf) cl "C" cmt w/0.2% CD-32, 0.25% R-3, 0.25# CF. Circ 108 sx cmt to pit. Released drilling rig on 6/9/13. Plan to pressure test 5-1/2" csg during completion operations.
