6/11/13 - Tubing slight blow, casing 300 psi. Loaded tubing with 33 bbls, did not pressure up. Pumped 80 bbls on a vacuum. NU BOP. NOTE: sinker bar was inside tubing.
 6/12/13 - Opened up well and had no pressure. Latched up and loaded tubing with 24 bbls 3% KCL. Pressure tested tubing to 500 psi for 20 min, held good.
 6/13/13 - Opened up well, had no pressure. Loaded casing with 70 bbls 3% KCL.
 6/17/13 - Acidized Morrow 8788'-8791' with 1500g 7-1/2% MSA acid.
 6/18/13 - Set 4-1/2" CIBP at 8740' with 35' cement on top. Set packer at 7400'. Pumped 100 bbls down casing, did not load. Moved packer up to 7340'. Pumped 80 bbls down casing to load. Pumped 1-1/2 BPM at 200 psi. Pumped 10 bbls. Moved packer up to 7090'. Loaded casing with 12 bbls. Pumped 8 bbls at 2 BPM at 250 psi. Pulled packer up to 6595'. Loaded casing with 11 bbls. Pumped 9 bbls 2.5 BPM at 250 psi. Released packer. RIH with packer and RBP to 7435'.
 6/20/13 - Released RBP.
 6/23/13 - Set packer at 7400'. Flanged well up. Pumped 2000g 20% HCL acid. Released packer. Set 4-1/2" ASI packer and 2-7/8" 6.4# J-55 tubing at 7400'.
