Drilled 7-7/8" hole to TD3918' on 7/27/13. Ran open hole logs. Set 5-1/2" 17# J-55 production csg @ 3910'. Cmted w/lead 300 sx (573 cf) 35:65 poz "C" cmt w/5% PF-44, 6% PF-20, 0.2% PF-13, 0.125# PF-29, 0.4# PF-46, & 3# PF-42 & tailed w/400 sx (536 cf) cl "C" cmt w/5% PF-13, 0.2% PF-167, 0.2% PF-65, 0.125# PF-29, & 0.4# PF-46. Circ 256 sx cmt to surface. We plan to pressure test 5-1/2" csg during completion operations.
