

- 7/15/13 - NU BOP.
- 7/16/13 - Ran GR/JB to 7510'. Set a 7" CIBP at 7495' and tagged. Loaded casing with 261 bbls. Pressured up to 500 psi, good. Spotted 25 sx Class "H" cement. Est TOC at 7358'. Spotted 35 sx Class "C" cement at 5426'. Est TOC at 5212'.
- 7/17/13 - Loaded casing with 20 bbls. Pressure tested casing to 3620 psi, ran chart for 30 min. Lost 100 psi, pressure down to 3520 psi, good. TIH with bond log tools. Went down to tag cement plug at 5212', went all the way down and tagged at 6745', 1533' low. Logged well from 3000' to surface with 1000 psi on well. TOC at surface. Re-spotted 35 sx Class "C" cement at 5426'. WOC. Tagged plug at 5235', good.
- 7/18/13 - Perforated Yeso 2448'-2530' (42). ND BOP. Waiting to frac well. Note: Name will change upon completion of Yeso.
