- Pump Class "C" Cement until full returns to surface
- POOH with 1" and wait 15 minutes and monitor well for fall back
- Top out well with cement
- Install 4" P & A marker per BLM requirements

Tag Bottom of well bore, circulate cement to surface. At cut-off verify cement to surface on all annulus. If not take remedial action.


