13. Describe Proposed or Completed Operation: Clearly state all pertinent details, including estimated starting date of any proposed work and approximate duration thereof. The contract Operations Coordinator for Raging Bull arrived at 6:48 AM on 8/29/13 and discovered the 15% HCL acid was leaking from the front manifold of the frac tank. He closed the butterfly valve isolating the manifold from the frac tank, which slowed down the leak. He notified the Devon consultant who called for vacuum trucks, backhoe, dump truck with sand and for new coated frac tanks to begin clean up. The leaks were coming from new welds on the manifold. Either the manifold was not recoated after welding or the coating was poorly applied.

A large area around the frac tanks and a 20' x 20' area off location were affected. Volume of spill was 167 bbls and approximately 1/2 of the acid was recovered by vacuum trucks and the rest was covered by sand. Jim Amos with the BLM advised this was satisfactory until Devon's operations were complete and then final cleanup and restoration would be required.
