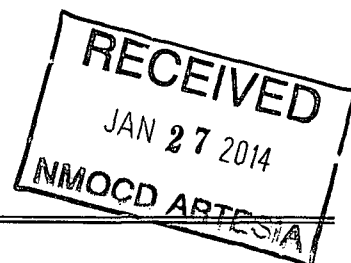

11/17/13 TD 7 7/8" pilot hole @ 9300'. Set cmt plug w/200 sx 9300-8600'. WOC & tag @ 8770'. Spot High-Visc pill 8600-8000'. Pump 340 sx plug 8000-7000'. WOC & tag @ 7153'. Dress off to 7270' (KOP).

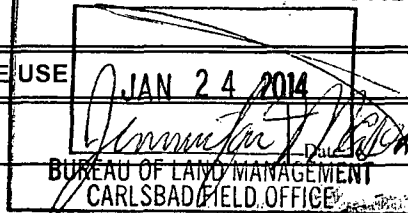
