
Burnett Oil Co. is requesting permission to plug and abandon this well following the below procedure:

Set CIBP between 50' and 100' above the uppermost perforation at 2896' (8/9/85). Cap CIBP w/25 sacks minimum. WOC and tag no lower than 130' above CIBP.

Spot a balanced plug @ 1494'. WOC and tag no lower than 372' (Covers top Yates, B/Salt, T/Salt, 8 5/8" shoe and various squeeze perforations). Will verify well no longer flowing to surface prior to proceeding with the surface plug.

Perforate @60' and attempt to squeeze cement to surface. At cut-off verify cement to surface all annulus. Ground level dry hole marker will be installed. Subsequent report will be filed upon
