

- Cimarex Energy Company contracted Talon/PE to do housekeeping activities at the County Line 1 Federal #1, an active well location.
- The visibly impacted soil around the heater treater was excavated to a depth of 0.5-foot deep. The southeast berm at sample location S-5 was excavated to 3-foot deep. A site map illustrating the sample location is attached.
- The excavated soil was transported to Lea Land, LLC an approved solid waste disposal facility.
- The berm was reconstructed and fresh gravel was placed inside of the heater treater berms.
