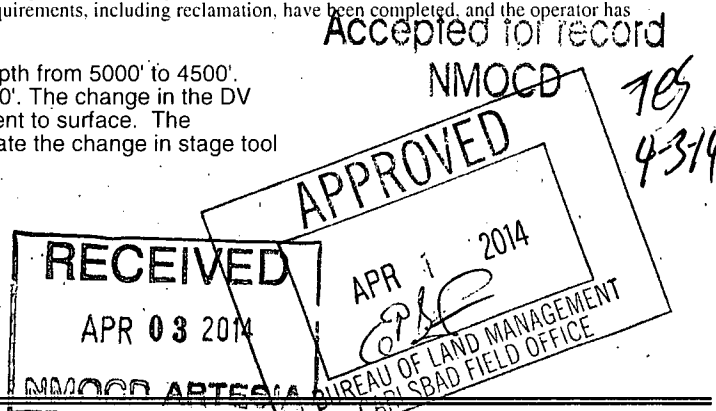

BOPCO, L.P. respectfully requests to change the 7" casing DV, tool depth from 5000' to 4500'. Drilling experience in the area shows a lost circulation zone below 4500'. The change in the DV tool set depth is being requested to help ensure the circulation of cement to surface. The following changes in cement volumes are being proposed to accomodate the change in stage tool depth:

7" casing Stage 1: Lead- 500 sks, Tail- 150 sks. 11,192' - 4,500' MD
Stage 2: Lead- 360 sks. 4,500' - Surface

No change will be made in approved cement slurry properties.
