

The pilot hole will be drilled into the Wolfcamp at a total depth of 10,600?. BOP/BOPE equipment will be tested to 5,000 psi-high and 250 psi low before entering the Wolfcamp formation. The attached cement plugs will be set once logging operations in the pilot home have been completed.


