Drilled 7-7/8" hole to TD3700' on 3/6/14 & set 5-1/2" 17# J-55 production csg @ 3694'. Cmted lead w/300 sx (571 cf) 35/65 POZ "C" cmt w/5% salt, 0.55% R-3, 5# LCM, 0.005# SF & 1/4# cello flake & tailed w/335 sx (445 cf) cl "C" cmt w/0.25% R-3, 0.25# CF, & 0.005# SF. Circ 150 sx cmt to surface. Released drilling rig on 3/6/14. Plan to pressure test 5-1/2" csg during completion operations.
