4/8/14 Drilled out all frac plugs. Circulate clean.

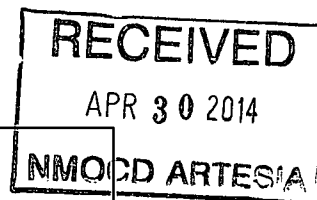
