Spud 14-3/4" hole 6/15/14, drill to 390' 6/15/14. RIH & set 11-3/4" 47# J-55 BTC csg @ 390', pump 20bbl FW spacer, then cmt w/ 250sx (74bbl) PPC w/ additives 14.2ppg 1.67 yield followed by 300sx (71bbl) PPC w/ additives 14.8ppg 1.34 yield, had full returns, circ 168sx (50bbl) cmt to surface. WOC. Install WH, test to 800#, RU BOP, test @ 250# low 5000# high. 6/17/14, RIH & tag cmt @ 344', test csg to 2150# for 30 min, test passed, drill new formation to 400', perform FIT test to 87psi, EMW=9.8ppg, pressure fell to 0# in 6 min. Decision made to drill ahead.

6/17/14 drill 10-5/8" hole to 3130', 6/18/14. RIH & set 8-5/8" 32# J55 LTC csg @ 3125', pump 20bbl FW spacer then cmt w/ 660sx (221bbl) Light PPC w/ additives 12.9ppg 1.88 yield followed by 230sx (54bbl) PPC w/ additives 14.8ppg 1.33 yield, had full returns, circ 113sx (38bbl) cmt to surface, WOC. Install Cameron pack-off bushing, test to 2000# for 15min, good test. 6/20/14, RIH & tag cmt @ 3070', circ hole, pressure test csg to 2750# for 30 min, tested good. Drill new formation to 3140', perform FIT test to 500#, EMW=12.2ppg, good test.
