Describe Cause of Problem and Remedial Action Taken.\*  Devon Energy was completing the well. When personnel arrived on the location a frac tank containing hydrochloric acid was found to be leaking. 70 barrels of frac aid was release and flowed under the tanks, with no fluids recovered. Baker Hughes treated the impacted area around the frac tanks with soda ash.

Describe Area Affected and Cleanup Action Taken.\*  The affected area measured approximately 10'x25' which remained on the location and did not impact adjacent pasture lands. Talon/LPE was called to remediate this incident. The impacted area will be scraped approximately 0.25-foot deep and disposed of at a NMOCD approved facility. The excavated area will be subsequently tested for pH. Upon acceptable results, the NMOCD and BLM will be petitioned for approval to backfill and reconstruct the location.
