Spud 14-3/4" hole 8/16/14, drill to 910'. RIH & set 11-3/4" 47# J-55 BTC csg @ 900', pump 30bbl FW spacer then cmt w/ 340sx (105bbl) PPC w/ additives @ 13.5ppg 1.73 yield followed by 240sx (57bbl) PPC w/ additives @ 14.8ppg 1.34 yield, had full returns during job, circ 59sx (70bbl) cmt to surface, WOC. Test BOP's @ 250# low 5000# high. Test csg to 2150# for 30 min, tested good.

The rig crew was attempting to install the wear bushing in preparation to run intermediate BHA in the hole. They could not get the wear bushing to pass through due to a large piece of rubber element sticking out from the Annular Preventer. We believe this element got damaged while pulling the test plug though it once BOP test was completed. They were able to replace the rubber element without removing the stack.

Received verbal approval from Ed Fernandez and Wesley Ingram-BLM to re-test just the BOP stack
