Devon Energy Production Company, L.P. respectfully requests to alter the 5.5" production cement job from a single stage to a two stage cement job.

A DV tool and packer will be set approximately 5000'. Cement will tie back a minimum of 500' inside the previous casing shoe. Cement volumes will be adjusted proportionately if DV tool depth needs to be changed. DV tool will be set a minimum of 50' below the previous casing shoe and a minimum of 200' above the current casing shoe.

The original COAs still stand with the following modification:

1. The minimum required fill of cement behind the 5-1/2 inch production casing is:

Operator has proposed DV tool at depth of 5000', but will adjust cement proportionately if moved. DV tool shall be set a minimum of 50' below previous shoe and a minimum of 200' above current shoe. Operator shall submit sundry if DV tool depth cannot be set in this range.

- a. First stage to DV tool:

Cement to circulate. If cement does not circulate, contact the appropriate BLM office before proceeding with second stage cement job. Operator should have plans as to how they will achieve approved top of cement on the next stage.

- b. Second stage above DV tool:

Cement should tie-back at least 500 feet into previous casing string. Operator shall provide method of verification.
