Spudded well on 6/21/14. Drilled 12-1/4" hole to 360'. Set 8-5/8" 24# J-55 csg @ 353'. Cmted w/300 sx (405 cf) cl "C" cmt w/2% Cacl2 & 0.25# C/F. Circ 80' sx cmt to pit. On 6/23/14, pressure tested 8-5/8" csg to 1500 psi for 30 min-OK.

Drilled 7-7/8" hole to TD4750' on 6/26/14. Ran open hole logs. Set 5-1/2" 17# J-55 production csg @ 4749'. Cmted w/lead 300 sx (571 cf) 35:65 poz "C" cmt w/5% salt, 0.2% R-3, & 0.25# CF & tailed w/620 sx (825 cf) cl "C" cmt w/0.6% R-3 & 0.25# CF. Circ 114' sx cmt to pit. Released drilling rig on 6/28/14. Plan to pressure test 5-1/2" csg during completion operations.
