4/1 to 4/25/07: Perforate Lovington Sand 3402-20' w/ 37 shots. Acidize w/ 1200 gals 10% NEFE, Frack w/ 732 bbls Xlink fluid and 9875# 16/30 sand. Run tubing and put on pump. Well completion report filed 5/7/07,

8/16 to 8/23/07: Perforate Premier sand 3128-30, 3197-98, 3278-90 w/ 26 holes. Acidize w/1344 gals 10% NEFE, Frack w/931 bbls Xlink fluid and 40,680# 16/30 sand.

9/26 to 10/09/07: Perforate Penrose 2825-30, 2862-80 w/48 shots. Acidize w/ 2500 gals 10% NEFE and Frack w/ 890 bbls Xlink fluid and 40,110# 16/30 sand.

This well produced marginally through April 2012 when it was shut in. An application to plug and abandon has been submitted and we are waiting for approval to P&A.
