While displacing intermediate cmt job, flow line plugged up causing cmt to come out over BOP stack & run down into cellar. Due to having to clean out the cellar & flow line, there was a delay before we were able to nipple down the BOP stack to set slips. By that time, cmt that came to surf set up & made it so that we couldn't set the slips.

Apache requests to cut off the 13-3/8" A-section wellhead & weld a plate on between the 13-3/8" surf csg & 8-5/8" interm csg. Plate will be outfitted with a 2" valve & a nipple with a pressure gauge on it to monitor the annulus pressure. Apache will then welded a new 8-5/8" A-section wellhead onto the 8-5/8" csg & plate. Our BOP equipment will be nipped up on the new wellhead.
