Spud well on 5/25/15. Drilled 11" hole to 445'. Landed 8-5/8" 24# J-55 csg @ 429'. Cmted w/250 sx (338 cf) "C" cmt w/2% Cacl2 & 0.125# CF. Circ 0 sx cmt to surface. Ran temperature log, which indicated cmt @ 180'. Ran 1" tbg down 8-5/8" annulus to 120' & pumped 100 sx cmt w/2% Cacl2. Still no returns. Pumped another 100 sx cmt & circ 1 bbl cmt to surface. On 5/27/15, PT 8-5/8" csg to 600 psi for 30 min-OK. Initiate drilling 7-7/8" hole for production csg.
