During production we will tie onto 9-5/8" x 7" annulus and install pressure transducer, once SCADA is rigged up we will monitor the pressure and have an alarm set at 1000 psi. In the event that the pressure exceeds 1000 psi, we will shut the well in and the BLM will be notified.
