- Spot acid across perfs 5099-5280 w/3000 gals 15% NEFE acid and across perfs. 4694 - 4860' w/3000 gals 15% NEFE acid.
- Will frac with Borate System.
- Flow back; clean out well; trip in hole w/pump and rods and place well into production.
