total 24 holes @ 2 SPF. Acidize same perforations w/total 2184 gals 15% FE acid. Frac same perforations in stages with  
total w/48,339 gals WFG-R33 gel w/33,304 gals 20% hot HCL & 4,708 gals cool 15% HCL. Run total 5054' 2.875" tubing  
and sucker rods. Put well to pumping to existing Jackson A Yeso Tank Battery.
