Tailed in with 200 sx "C" + 2% CaCl₂ (yld 1.34, wt 14.8). Cement circulated to surface. Tested casing to 1300 psi for 30 min. Ending psi 1290. WOC 26 hrs 30 min. Reduced hole to 12-1/4" and resumed drilling.
