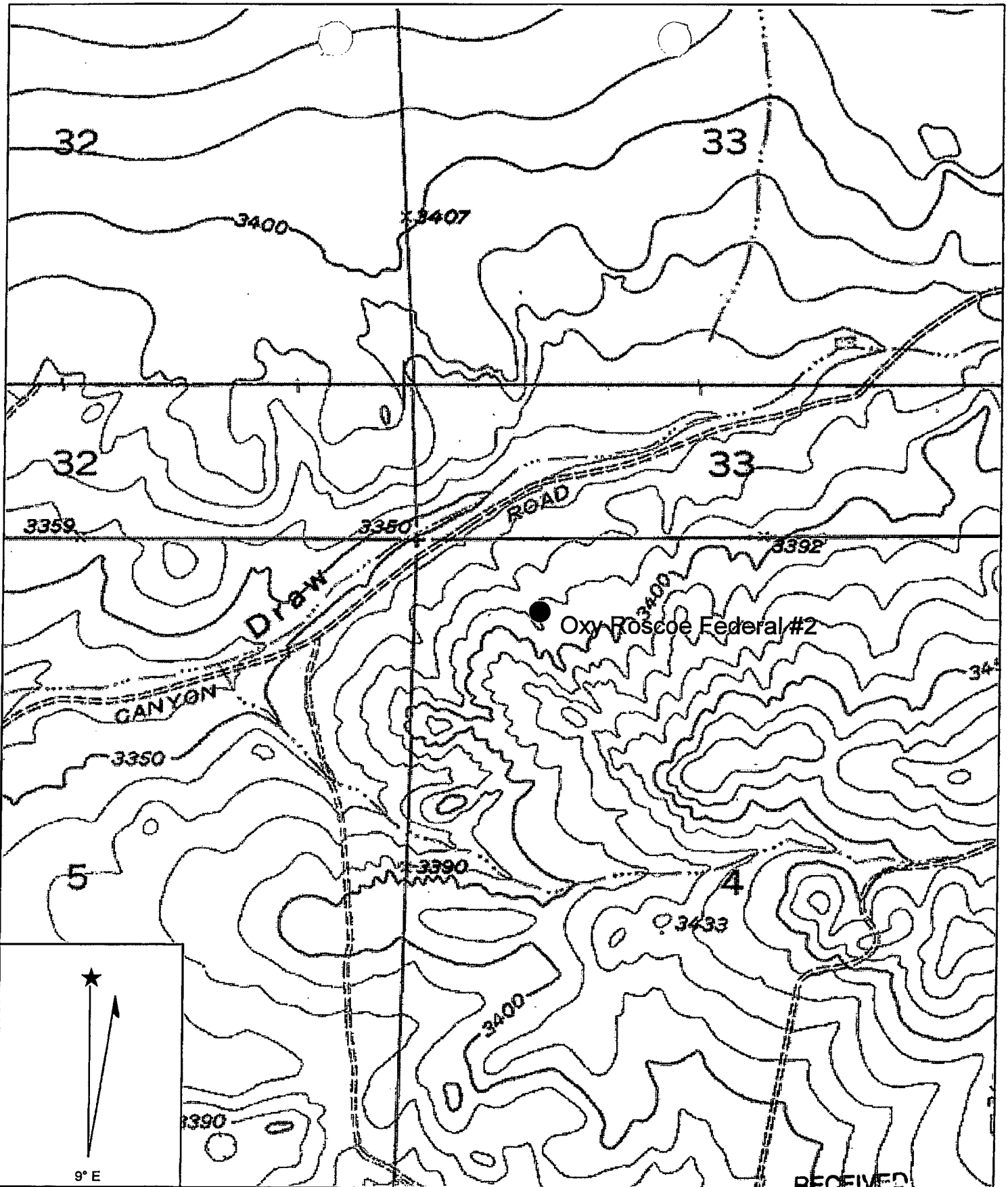

If there is evidence of contamination, the soil will be tested by lab and if contamination is confirmed, further remediation will be conducted according to guidelines.
The excavated area will be backfilled with clean soil and covered and contoured with three feet of soil or like material capable of supporting native plant growth to prevent erosion and ponding of rainwater.
A one call and a 48 hour notice will be provided to the Oil Conservation Division.
