We plan to trench bury the drilling pit at the Apache 25 Federal #14 as well as the pit contents and liner from HB 10 Fed #5 (NMNM81616, API 30-015-33836 Sec. 10, T24S R29E, Eddy Co. NM). We will line the trench with 12 mil liner and cover with 20 mil plastic. We will then cap with 3' of native material capable of supporting native plant growth, and contour the pit area to prevent erosion and ponding of rainwater over the site.
